- I. **CONVENE REGULAR MEETING/PLEDGE OF ALLEGIANCE:** The meeting was called to order by Mayor Buck Hakes who led the audience in the Pledge of Allegiance.

The experience of working at The Wall was very moving. The Police Department had no calls; and, thank you to Joe Duran for keeping the restrooms in tip top shape. **Don Daniel** reported that we should be getting a new contract from the Mine this week reflecting the water rate increase. **Veldean Petri** reported on her attendance at the Southern Teller County Transportation Committee meeting and its development of a questionnaire to determine needs; attendance at a CML breakfast regarding 60, 61, and 101. She invited everyone to come to Sunnyside Cemetery and enjoy the solitude. She reported that the E Clampus Vitus #100 had installed a new plaque at Potters Field. The Gold Camp Economic Development Council celebrated its first anniversary and they are having meetings once a month. Black Hills Energy will be planting 100 trees between the substation and the burm. Talks with CDOT have not been fruitful regarding getting signs to Victor on I-25. She is hopeful that the new City flag and a sign will be installed at the east Victor City limit. A small ceremony was then held to honor Victor's July Volunteer of the Month, Glori Thurston, and she was presented an engraved glass gift from the City. **Michael Wallace** thanked Veldean Petri for serving on the City Council. We are meeting with the drainage engineer on Friday night and will begin the project as soon as possible. Work on Mary Bielz' building will start in October or November. He also reported in talking to several people from the Victor Lowell Thomas Museum that there have been nothing but good comments about Victor and the positive things that are going on.
