Conditions of Burn:

1. Prior to commencement of each open burn, the fire department MUST be notified by calling the Chief at \_\_\_\_\_.
2. Burning is allowed only during daylight hours and shall not occur during periods of high winds, extreme fire conditions or City or County-designated Burn Bans.
3. Burns shall be constantly attended by a person at least 18 years of age, knowledgeable in the use of fire-extinguishing and limitations of this permit. Attendee shall supervise the burn until the fire has been **completely** extinguished.
4. Open burning of any paper products is PROHIBITED.
5. A garden hose connected to a water supply or other approved fire-extinguishing equipment shall be readily available for use at the burn site.
6. The fire department is authorized to require that open burning be immediately discontinued if it is determined that smoke emissions are offensive to neighboring properties or if the open burning constitutes a hazardous condition.
7. Open burning shall not be conducted within 50 feet of any structure or other combustible material. Conditions which could cause the fire to spread to within 50 feet of a structure shall be eliminated prior to ignitions (weeds, combustibles and trash).
8. Emergency vehicle access must be available in case of an emergency.
